## CONDITIONS OF SALE

**Pricing:** Pricing is effective for weeks 40–39, 2008/2009 for Unrooted cuttings only. Pricing stated as price per one invoiced cutting unit (eaches), net to broker. All prices are F.O.B. point of origin. Tag and royalty will be additive per published rates. Prices are subject to change without notice.

**Discounts:** Discounts apply to non-quoted customers only. Volume discounts are calculated on an annual earned volume per customer and based on customer's order volumes summed for weeks 40–39, 2008/2009. Prices are set annually at the beginning of shipping season based on the annual volume discount tier from prior season's total purchases. Royalty and freight are not subject to any discounts. Please contact Customer Service for your specific quote requests.

**Tags:** Tags for all products sold by Ecke are optional. The system will automatically default to a "yes tag" option and tags will ship with your order. If your customer wishes to not receive tags your order must clearly specify "no tag". Please allow 10 business days on all replacement tag orders.

**Invoicing:** Invoices will be mailed or faxed within 5–7 business days from the Monday of that ship week.

**Claims / Returns:** All claims are processed through our Encinitas, CA office. All claims must be submitted in writing within eight (8) business days of receipt of the shipment. To protect the integrity of our certified production systems, no returns are accepted.

**Cancellations:** Rooted and callused orders canceled prior to plant date can be canceled without penalty. Rooted and callused orders cannot be canceled after product has been planted without preapproval by Customer Service. Refer to Ecke Flower Fields or Ecke Geranium–Oglevee products Program Guide(s) for lead times by variety. Unrooted orders can be canceled six (6) business days prior to ship date. In the event that an exception is made for cancellations after plant the order is subject to a \$10.00 per tray restocking fee.

**Warranty:** All orders are subject to confirmation by Ecke Geraniums, LLC, and crop conditions. Ecke Geraniums, LLC, warrants, to the extent of the invoice price, that the plant material is sold as described in this catalog, within recognized tolerances. No further warranty is given, expressed or implied.

Paul Ecke Ranch warrants, to the extent of the purchase price, that all cuttings are sold true to name and as described with recognized tolerances. Paul Ecke Ranch makes no other warranty, express or implied, concerning the cuttings, and expressly disclaims any and all other warranties, including any warranty of the merchantability or fitness for customer's particular purpose. Customer's sole and exclusive remedy for any breach of this order agreement, including but not limited to any claim under the warranty in this paragraph, shall be return of the price paid for the affected cuttings. Customer acknowledges and agrees that the maximum liability of Paul Ecke Ranch for any claimed breach of the warranty in this paragraph, or for any other claim of defective or non-conforming cuttings, non-delivery or late delivery, or otherwise, shall be limited to the price paid for the affected cuttings.
