CONDITIONS OF SALE

Program Licensing: A license is required for customers purchasing trial packs. Further, depending on declared intentions, customers may be required to obtain a licensing agreement from Paul Ecke Ranch or be identified by a retailer as an approved member of a specified sales channel.

Pricing: Pricing is effective for ship week 40, 2009 through week 39, 2010 and stated as price per one invoiced cutting, inclusive of Intellectual Property Fee (IPF) and freight. Prices are subject to change without notice.

Freight: Freight charges stated as cost per tray. An adjusted minimum freight charge will be applied to order volumes below the stated unrooted full box minimums.

Discounts: Special program-based volume discounts are available for qualified customers. Please contact customer service for further details.

Invoicing: Invoices will be mailed or faxed within 5 to 7 business days from the Monday of that ship week.

Claims>Returns: All claims are processed through our Encinitas, CA office. All claims must be submitted in writing within eight (8) business days of receipt of the shipment. To protect the integrity of our certified production systems, no returns are accepted.

Cancellations: Cancellation or changes can be made no later than the production day prior to scheduled shipment.

Warranty: All orders are subject to confirmation by Paul Ecke Ranch and crop conditions. Paul Ecke Ranch warrants, to the extent of the invoice price, that the plant material is sold as described in the 2010 The Flower Fields® product catalog, within recognized tolerances. Paul Ecke Ranch makes no other warranty, expressed or implied, concerning the cuttings, and expressly disclaims any and all other warranties, including any warranty of the merchantability or fitness for customer's particular purpose. Customer's sole and exclusive remedy for any breach of this order agreement, including but not limited to any claim under the warranty in this paragraph, shall be return of the price paid for the affected cuttings. Customer acknowledges and agrees that the maximum liability of Paul Ecke Ranch for any other claim of defective or non-conforming cuttings, non-delivery or late delivery, or otherwise, shall be limited to the price paid for the affected cuttings. Customer acknowledges that they shall not be entitled to recover any other claimed consequential damages.
